Agreement.

1. Individual community members with a key card may access the facility between 5 a.m. and 10 p.m. for the purpose of personal exercise with the exceptions noted below.
 - For the safety of students, the facility is closed to public access, even with a key card, when an Olympia School District (OSD) school is conducting classes, activities, or athletic practices and games.
 - In order to preserve the turf field, key card holders' use is limited to lanes 7 and 8 of the track. Use of the turf field is limited to scheduled and approved community user groups*, supervised school classes/activities, and supervised school/district athletic practices/games and is **not** available for other community use or personal exercise.
 - Community members are welcome to watch the practices and games of approved community groups. If using the track during these activities please do so in a manner not distracting to the user group and spectators.
 - Unauthorized users of this facility will be prosecuted under the full extent of the Olympia Municipal Code Section 9.40.080 – Criminal Trespass
2. Commercial use of the facility is prohibited. As a result, use of the facility by personal trainers or others conducting these activities is prohibited.
3. No food, gum, seeds, shells, sports drinks or glass containers are allowed on the track or field surfaces – a \$200 cleaning fee will be charged for violations.
4. Parking or any use of a vehicle (including bicycles, skateboards, scooters, skates, etc.) is prohibited inside the fenced area.
5. Use of the grandstand area and/or steps for personal exercise is limited to walking stairs and is done at the individuals' own risk since stairs can be slippery and uneven. **The seats may not be used for any form of exercise.**
6. Approved service animals are the only animals allowed inside the fenced area.
7. The District has installed security cameras at access gates and in locations to view the field and track. Video will be reviewed as necessary if there is facility misuse or damage.
8. Misconduct, misuse, possession or use of intoxicating beverages and/or controlled substances, the carrying of weapons or other violations of established regulations, noted in OSD Procedures 4260-C or D and/or the community access agreement will be sufficient cause for denial and/or termination of access.
